



**Official Conditions for 2020-2021
Reputation Resolutions Scholarship Competition**

This document specifies the terms and conditions for the scholarship program offered by Digital Revolution, LLC dba Reputation Resolutions (the "Company"), which owns and operates the website located at <https://reputationresolutions.com>. By submitting an application for the scholarship, you are agreeing to be bound by these terms and conditions.

1. Any changes to the terms and conditions of the scholarship opportunity will be updated on this terms sheet as soon as possible. Applicants are responsible for ensuring that they have the latest version of this document at the time of application.
2. This scholarship application requires the completion of a 750-1500 word essay. The essay must be submitted (along with a fully-completed competition application form, available at <https://reputationresolutions.com/reputation-resolutions-scholarship>).
3. Applicants are encouraged to be creative and share business ideas, current business goals, or even explore what entrepreneurship means to them, especially within their community, in their essay. It doesn't matter which stage of building a business that applicants are at; the point is to demonstrate passion and purpose
4. All applicants must be U.S. citizens or permanent legal residents of the United States. An applicant who is a minor in his or her state of residence must obtain and submit written permission from his or her parent/legal guardian to apply.
5. All the candidates must be enrolled as a full-time college or university student for the 2020-2021 academic year or a high school senior who has already been accepted to an accredited college, university, design, or trade school and be in good academic standing.
6. One (1) applicant ("the recipient") will receive a one-time \$2500 scholarship to be applied to qualified college expenses. Funds will be released by the Company and will be made payable directly via mail to the accredited college or university designated by the recipient in connection with his/her essay submission.
7. Submissions must be received on or before April 30th, 2021, to be considered for the scholarship. After the 15th day of May 2021, the winner will be selected by a team of judges following the review of all entries received before this deadline. Entries are judged on creativity and insight. The Company has sole discretion of selecting scholarship recipients.
8. The recipient will be notified directly by the Company by email at the email address provided by the recipient upon submission of his/her entry.
9. The recipient's essay may be posted on the <https://reputationresolutions.com> website. By submitting an application, you acknowledge and agree that the Company may publish your article online and that it may be viewable and accessible by the general public.
10. The Company reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God, or any actual or anticipated breach of any applicable law or regulation or any other event outside of The Company's control.
11. Judges will include the Company's staff. If the recipient is disqualified or fails to contact Company within 24 hours of being notified of the results, Company reserves the right to determine an alternate winner or not to award the scholarship, at its sole discretion.
12. Each applicant's designated institution must be accredited and listed on the official website

of the U.S. Department of Education. Applicants attending military academies are ineligible for this scholarship. All school transfers are subject to accredited approval.

13. By participating in this program, each applicant expressly:

- a. Releases the Company and its employees and agents from any liability or claim of any kind or nature for any loss, claim, and damages or injury of any kind associated with participation in the program and acceptance, possession, or use of any prize.
- b. Accepts and agrees to be bound by these rules and Company's decisions relating to participation in the program, selection of recipients, and awarding of scholarships, all such decisions being final.
- c. Agrees that Colorado law governs this program without regard to conflicts of law principles and consents to the jurisdiction and venue of the federal, state, and local courts of Colorado for the resolution of all disputes pertaining to or arising from this program.

14. The recipient must complete an affidavit of eligibility and release (to be signed by his/her parent or legal guardian, if the beneficiary is a minor) on forms to be provided by the Company.

15. The recipient must be actively enrolled full-time as a college freshman, sophomore, junior, senior or grad student in the 2020-2021 academic year and for the 2021 Fall Semester without interruption, barring illness, emergency or military service, or a high school senior who has already been accepted to an accredited college, university, design, or trade school.

16. It is the recipient's responsibility to verify receipt of funds with his/her designated institution and notify the Company should the award check not arrive on or about 30 days from the issue date.

17. By entering, each Applicant represents that his/her submission is a work of original authorship created solely by the applicant and agrees that the Company will have a perpetual, royalty-free, exclusive, worldwide right and license to use the submission in any manner.

18. The Company reserves the right to disqualify any entry for any reason, including without limitation: materials not suitable for general public viewing; obscene, lewd, or offensive materials; the use of third party content or other materials not authored by the applicant; materials previously published or entered into any other competition; and misrepresentation or fraudulent information submitted by the applicant.

19. The Company is not responsible for lost, late, damaged, or illegible submissions, faulty transmissions, mechanical or technical errors, or submissions containing any virus or other system malfunction. Judges' decisions are final.

20. It is the applicant's responsibility to notify the Company of any changes in contact information that may affect the Company's ability to contact the applicant during the scholarship award period. If, after reasonable attempt, the Company is unable to contact the recipient, the recipient will forfeit the award, and the Company may award the scholarship to another applicant.

21. Any taxes resulting from or attributed to the scholarship are solely the recipient's responsibility.

22. The Company reserves the right to alter, discontinue, or cancel this program at any time without notice for any reason, including in the event of fewer than 20 applicants. Only one entry per person will be accepted.
